#### Office of the Principal CKB Commerce College, Jorhat Notice Inviting Tender

Sealed Tenders affixing court fee stamp of Rs.8.25 (Rupees eight and twenty five paisa) are hereby invited from the registered experienced APWD (Building) Class – I (C) and II contractors in two bids (Technical bid and financial bid) for upgradation of sports facilities to CKB Commerce College, Jorhat under 'RUSA' Grant. Tender will be received upto 2-00 P.M on 19-11-2019 and will be opened in the same day at 3-00 P.M in the office of the Principal, CKB Commerce College, Jorhat. The details are available in the college website (<a href="http://ckbcc.org">http://ckbcc.org</a>). The total estimated cost for upgradation of sports facilities is Rs. 14 Lakh (approx.). The cost of tender paper: Rs.1000 in the form of Demand Draft.

#### Terms and Condition for Upgradation of Sports Facilities

- 1. Sealed tenders are to be addressed to the Principal, CKB Commerce College, Jorhat, Assam and sealed cover should be super-scribed as "Tender for Sports facilities" in capital letters.
- 2. The Contractor has to submit two bids. One is Technical Bid containing Registration, Experience, GST payments, PAN Card, EPF, Labour License etc. and another is Financial/Price Bid containing rates only.
- 3. If for any reason the last date of receiving and opening of Tender paper is declared holiday then next working day will be considered as the last date of receiving/opening of Tender.
- 4. Awarded Contractors are to deposit a Security Money @ Rs. 8% of total Tendered cost.
- 5. The bid documents are not transferable and the seal and signature of the authorized official of the contractor must appear on all the papers and envelopes submitted.
- 6. Rates quoted for the items should be on the door delivery basis. With break ups as per details i) Basic price ii) Sales Tax (GST) iii) Installation charge and if any.
- 7. Rates should be quoted both in words and figures clearly.
- 8. Overwriting of rates either in words or figures will not be accepted in any case and the Tender will be rejected if found overwriting.
- 9. Photocopy of Trade license, GST registration certificate are required.
- 10. Proof of Purchase Orders/Work Experience for similar kind of works completed in last three years have to be submitted along with tender.
- 11. Rate, specification, makes and model number should be mentioned clearly.
- 12. Tender should be supported by catalogue/brochure for each of the items as available.

- 13. The quoted rate/cost of the entire item should be including Delivery/freight charge, installation and other charges (if any) for destination F.O.R. CKB Commerce College, Jorhat, Assam.
- 14. The quoted components must be warranted for a minimum of one year in favour of "Principal, CKB Commerce College, Jorhat".
- 15. The successful bidders will be required to supply the ordered item(s) within 30 days from the date of issuing of supply order and for upgradation of sports facilities work to be started within 30 days from work order. Failure to which the order will be treated as cancelled.
- 16. Full payment will be made through PFMS (Public Financial Management System) via online mode only after the proper supply, successful installation and demonstration. A mandate form mentioning all bank details of the bidder duly signed by the bank has to be submitted by the bidder. The following documents to be submitted for payment:
  - i) Three copies of supplier's invoice showing goods description, quantity, unit price and total amount;
  - ii) Consignee Receipt Certificate in original issued by the authorized representative of the consignee;
  - iii)Inspection certificate issued by the nominated person/committee/agency, in case of instruments.
- 17. Request for advance payment in any case will not be entertained.
- 18. The Principal reserves the right to modify or cancel the entire process of purchase without assigning any reason.
- 19. The Terms and Condition should be read carefully and signed by the bidder.
- 20. The quoted price should be valid for at least 180 days
- 21. The earnest money 2% (1% for OBC/MOBC & SC/ST) of the Tendered value in the form of FDR Pledged to the Principal of CKB Commerce College.
- 22. The management committee is not bound to accept the lowest bid.

<u>Note</u>: The original documents like GST/PAN/OEM Authorization for contractors registration certificate, Bank account details for online payments etc. will be verified before issuing work order/supply order. Failing which his/her tender will be treated as "INVALID".
