### MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING is entered into on this 2<sup>nd</sup> day of September, 2019 BETWEEN CKB Commerce College, Jorhat – 1, Assam represented by the principal of CKB Commerce College, Dr. Ranjit Sarma S/O : Late N.C. Sarma, R/O : Shastripith, Choladhara, Jorhat One part, herein after called as the "FIRST PARTY".

AND

All Assam Amateur Muaythai Association, H.O. : Near Chariali Atila Gaon, Jorhat – 785001, Assam, Govt. Registered No. RS. JOR/238/A83/08/2002-2003, affiliated to United Amateur Muaythai Association-India, Estd. : 1999, represented by A. Rakesh Meetei Master of Muay Thai (Gold Morgkol) (Refere and Judge Internation passed from Bureau of Sports Development Govt. of Thailand) of the other part, hereinafter be called as the "SECOND PARTY".

WHEREAS, All Assam Amateur Muaythai Association, H.O. : Near Chariali Atila Gaon, Jorhat – 785001, Assam, Govt. Registered No. RS. JOR/238/A83/08/2002-2003, affiliated to United Amateur Muaythai Association-India, Estd. : 1999, is conducting muaythai classes in the premise of the first party since long and today the second party has

approach the first party and requested the authorities of the college to allow him to continue with the Muaythai / self defence classes is the premise of the First Party and Second Party agrees to provide their vacant premises for the said classes under the following terms and conditions :-

NOW THIS DEED WITNESSES AS FOLLOWS :

- 1) That this agreement shall be initially for the period of 3 years and shall be renewed with the mutual understanding of both the parties.
- 2) That the second party shall maintain the dignity of the college and shall not indulge any illegal activities within the college premises.
- 3) That the classes shall be conducted by the second party and the name of the college must be printed in the T-Shirts of the students worn by them during class session.
- 4) That the Second Party shall have to provide one compulsory Muaythai / self defence classes for the students of the First Party between 2:30 – 3:30 PM on every working day.
- 5) That the Second Party shall provide the Muaythai / self defence classes / courses to the students of the First Party free of cost.
- 6) That the First party shall print the time and day on which the classes will be held, in their week / daily college routine.
- 7) That the period of the Muaythai / self defence classes / courses must be within 16<sup>th</sup> January to 15<sup>th</sup> April and 1<sup>st</sup> August to 30<sup>th</sup> October each year.
- 8) That any other extra event / programmes related to this classes / courses can be organised in the college premises on the term and conditions which will be mutually decided by both the parties at the time of events / programmes.
- 9) That the First Party agrees to provide the Second Party for the practice session of the students :-
  - a. The open area / ground of the college premise of the First Party.
  - b. Drinking Water free of cost.
  - c. Electricity free of cost.
  - d. Varandha of the college campus.

- 10) That the Second Party must keep the college premise neat and clean and in good condition the above mentioned facilities provided to Second Party by the First Party and in case of any damages or harmful activities to the properties of college the responsibilities and the cost damages must be born by the Second Party.
- 11) That the First Party agrees to provide the above mentioned classes to their students and to use the college premises or other above mentioned facilities to the Second Party only to propagate the social sports spirit and keeping in mind the health and self defence activities of their students.
- 12) That the Second Party should adhere to the above conditions and observing all the conditions of First Party shall not put any hindrance to the smooth functioning of the said classes.
- 13) That for any untowards incidents in conducting the classes by the Second Party the latter shall be fully responsible without shift of any burden to the First Party.
- 14) That the First Party shall have the absolute right in case of any irregularities to terminate this deed of agreement or memorandum of understanding, without any prior notice to the Second Party.
