The Jorhat District Badminton Association established in 1954, an elected body which promote and develop the game with a sole motive of training the young peddlers by special coaches across the District represented by General Secretary, Jorhat District Badminton Association , Mr. Digonta Buragohain, S/o: Late Krishna Kanta Buragohain, Kushal Nagar, Jail Road, Jorhat, the other part, hereinafter be called as the **“SECOND PARTY”**.

This Memorandum of Understanding will come into effect from **1st August, 2022**.

The C.K.B. Commerce College, which is having a beautiful Indoor Stadium in their own premises willing to give their stadium to the Jorhat District Badminton Association for training of their young shuttlers for a period of Seven Years subject to extension for a specified period.

The College will hand-over the stadium only for practice of student category. The timing of practice session will be 5 A.M. to 7.30 A.M. & 3.00 P.M. to 9.00 P.M.

During the practice session, the college authority and the Association will appoint a person who will look after the stadium. The opening & closing of the stadium & maintenance of it including the Electricity & Water connection will be entrusted with the said person. He will be responsible for the smooth functioning of the stadium.

A Joint Monitoring Committee will be formed by the College authority & Jorhat Badminton Association. The Committee will review any matters related to the stadium and a meeting will be held every month of a mutually agreed date & time.

The Jorhat District Badminton Association will bear the expenditure of Electricity & maintenancé staff and other minor repairing works such as replacement of blub and any other small repairing jobs.

The Jorhat District Badminton Association will not enter into any financial package with the college authorities for a certain period. The Association is solely dependent on Annual fees from the players. It does not receive any grant or financial package from any other sources. Hence, in the initial stage, the Association will not be able to contribute any financial aid to the college authorities. However, in the near future, the Association will definitely think of contributing financial support for the development of its existing infrastructure.

The Jorhat District Badminton Association will strictly impose various measures to protect the academic atmosphere in and around the college premises.

The regular practicing players will be allowed to enter only inside the stadium during the stipulated time. The Association will strictly take measure to restrict the players as well as their guardians to go beyond the stadium during the practice session.

As the CKB Commerce College is Tobacco free Campus, use of tobacco products is strictly prohibited which will be ensured by Jorhat District Badminton Association.

The Association may conduct special coaching session, as well as may organize various National & State Level Tournaments. Hence, the timing will be extended during that proposed tournament subject to the prior permission obtained from the College authority.

Only regular practice players, their guardians and officials of the Association earmarked by them will be allowed to enter into the stadium. No intruders will be allowed to enter the college premises, or in and around the stadium during the practice session.

The Jorhat District Badminton Association will encourage a few potentially marked students of the College as well as a few faculty members for special training by specialized coaches of the association on a mutually agreed time.

During any Sports event of the College where "D.N. Sarmah Sports Complex" will be used, the Association will co-operate the college authority.

For entry and exit of the players, guardians and other officials only Gate No. 2 of the College will be used.

Both the parties have the right to terminate the agreement before the expiry of the agreed period through mutual discussion.
